Whereas, the Department of Skill Development, vide their communication No. Edu/Tech/Genl/61/2019 dated:30.09.2020, referred two(02) posts (OM:01, RBA:01) of **Programmer**, to the J&K Public Service Commission, for being filled up in accordance with the relevant rules of the Department; and,

Whereas, the J&K Public Service Commission vide Notification No. 06-PSC (DR-P) of 2022 dated: 24.01.2022 advertised the said posts; and,

Whereas, in response to the above notification, a total of 291 applications were received; and,

Whereas, a written test was conducted on 16.11.2022, in which 136 candidates appeared. The result of the written test was declared vide Notification No. PSC/Exam/2022/39 dated 19.12.2022 in pursuance of Rule 32 of the J&K Public Service Commission (Conduct of Examinations) Rules, 2005 read with Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021 as amended up-to-date and 10 candidates were called for interview; and,

Whereas, the viva-voce of candidates was conducted on 23.08.2023 with the assistance of Experts.

Now, therefore, on the basis of the performance in the written test and interview in pursuance of Rule 43 of the J&K Public Service Commission (Business & Procedure) Rules, 2021 and other related parameters, the merit of the candidates who appeared in the interview is enclosed as **Annexure-“A”** to this Notification.

Consequent upon the facts stated here-in-above, the provisional **select list** against the available posts is given in **Annexure-B** to this Notification.

Note:-

1. The Commission reserves the right to have certificates/documents of the candidates verified, if at any later stage found expedient to do so. The Selection of the candidates is purely provisional and is subject to the outcome of writ petition(s) pending before any competent Court of law.
2. The selection is provisional and objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
