Whereas, the Health and Medical Education department, vide indent No. HD/Drug/24/2020 dated 25-09-2020 followed by No. HD/Drug/24/2020 dated 07.01.2021. and No. ME/NG/83/2020 dated 08.03.2021 and No. HD/Coord/64/2020 dated 25.09.2020 and No. HD/Coord/63/2020 dated 25.09.2020 and No. HD/ISM/62/2020 dated 25.09.2020 and No. HD/Coord/64/2020 dated 05-03-2021 and No. ME/NG/83/2020 dated 28.09.2020, among other posts, forwarded the requisition for making direct recruitment to the 87 posts under various items, as per the following break up:

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 87 posts, among other posts of Health and Medical Education Department, vide Advertisement Notification No. **02 of 2021 dated 26.03.2021**; and

Whereas, as per the Notification, the selection to these posts was to be made on the basis of Written Examination only and, accordingly, the JKSSB conducted the Computer Based Test (CBT) for these posts in multiple sessions/slots w.e.f. **17.08.2021 to 25.08.2021**; and

Whereas, on the basis of merit obtained by the candidates in the written test, the Document Verification was conducted in terms of Notice No. **SSB/CoE/Health/2021/7598-7606** dated **09.11.2021**, from **20.11.2021 to 04.12.2021**, by the DV Committees constituted vide Order No. **380-SSB of 2021** dated **17.11.2021** followed by Order No. **386-SSB of 2021** dated **18.11.2021** and Order No. **389-SSB of 2021** dated **18.11.2021**; and

Whereas, DV in respect of left out candidates was conducted from **18.10.2022 to 19.10.2022** by committee constituted vide Order No. **348-SSB of 2021** dated **30.11.2021**; and

Whereas, the candidates figuring in the consideration zone for the

above mentioned posts were allowed to indicate the order of preference for various posts/items through a link provided on the official website of the Board www.jkssb.nic.in from **17.11.2021** upto **25.11.2021**, vide Notice No **SSB/CoE/Health/2021/7695-7704** dated **17.11.2021**, the date for which was extended upto **30.11.2021** vide Notice No **SSB/COE/Health/2021/7958-67** dated **25.11.2021**; and

Whereas, the selection committee for preparing the selections to the aforementioned posts was constituted vide order no **344-SSB of 2021** dated **29.11.2021**, that was superseded by the constitution of a committee vide order no **277-SSB of 2022** dated **8.10.2022**; and

Whereas, the matter was in the Hon'ble Central Administrative Tribunal against the said selection process in the case of Hilal Ahmad Bhat and others vs UT of J&K and others case, wherein, the Hon'ble CAT Srinagar clubbed TA No. 5646/2021 and TA No. 221/2021, that were disposed of by way of a common order on 15.11.2022 with the following directions:

" In view of the above discussion, it is clear that the applicants are governed by the rules of 2009 which clearly state that the engagement of applicants was on academic arrangement basis for a period of one year extendable upto a maximum of six years or till selection is made in accordance with the recruitment rules. The applicants had also executed an agreement/contract with the respondents that they will not claim for regularization of their services, The respondents were well within their jurisdiction and competence to issue the advertisement notification 02 of 2021 dated 26.03.2021.

With these observations, TA 5646/2021 and TA 221/2021 along with all the MAs are dismissed. All the interim orders stand vacated. The respondents are at liberty to proceed further to complete the process of selection and appointment of candidates as per advertisement notification No 02 of 2021 dated 26.03.2021. No order as to costs"

Whereas, the petitioners, aggrieved of the final order of Hon'ble CAT Srinagar, mentioned above, approached the Hon'ble High Court of J&K and Ladakh, wherein the **Hon'ble High Court of Jammu & Kashmir and Ladakh** at Srinagar in WP(C) No. 2682/2022, while pronouncing its Judgement on 31.01.2023, upheld the decision of **the Hon'ble Central Administrative Tribunal, Srinagar Bench** and maintained that:

"In view of the above and having regard to clear position of law enunciated by the Supreme Court in Uma Devi (3), we fully concur with the view taken by the CAT, Srinagar Bench. We find no merit in these petitions and the same are, accordingly, dismissed. The interim directions, if any, shall stand vacated. The respondents are free to conclude the selection process initiated vide advertisement Notice No. 02 of 2021"



Whereas, after receiving the aforementioned directions from the Hon'ble High Court of Jammu & Kashmir and Ladakh on 31.01.2023, the selection committee started preparing the provisional selection list, by following the principle of *Merit-cum-Preference*; and

Whereas, during the course of selection, the selection committee was faced with the issue of ambiguity in the eligibility requirements for two item numbers, i.e., 180 and 226. As per the Indent, the requirement for item Nos. 180 and 226 was "10+2 or above qualification with Medical Assistant/Pharmacist training from recognized institute" and it did not mention whether Degree or Diploma or both in the relevant field, were the eligibility requirements for the aforementioned two items, and hence the selections to these two item numbers could not be framed; and

Whereas, the issue was placed in the Board in its 223rd Board Meeting and it was decided to take up the matter with the indenting department, that whether Degree or Diploma or both in the relevant field, were the eligibility criteria for the said two posts. And the same was communicated to the indenting department vide letter no: **JKSSB/Sel/Secy/2023/521-25 dated 26.04.2023**. The Indenting Department vide letter No. **MU-NG/253/2023-02 Dated 16.06.2023**, has endorsed the following clarification provided by the J&K Paramedical Council, issued vide letter No. **SPMC/GMC/Sgr/2722-2725 Dated 10.06.2023**:

"...both Degree and Diploma are eligible for the item No. 180 and 226 reflected in the advertisement notice issued by JKSSB vide No. 02 of 2021 dated 26.03.2021"

Whereas, keeping in view the afore-stated facts and clarification, the Provisional Selection list so prepared, by following the principle of *Merit-cum-Preference*, was approved by the Board in its 229th Meeting and subsequently notified vide Provisional Notification No. JKSSB/Sel/Secy/2023/731-40 Dated 19.06.23; and

Whereas, the candidate/s aggrieved with this Provisional Selection were asked to represent through the email address healthhelpdeskjkssb2023@gmail.com within **three** days from the date of Notification of the Provisional Selection List; and

Whereas, in response to the Provisional Selection List, a total of 18 unique representations were received in the Board, 5 of which were regarding corrections in particulars and the needful, in all these cases, was done after due approval in the Board. 9 representations were received with the claim for inclusion in the selection list which were found devoid of any merit. The representations other than the ones mentioned above, that were deliberated in the Board are tabulated below:

Whereas, both HCL, HCH vacancies are to be considered in the ratio 1:1, one candidate with the highest merit among the eligible categories of disabilities namely Mr. Amit Sharma (DV No. 1539 JMU) with a percentile of 93.6977 has already been selected in OM/HCL category under item No. 180 leaving only one post of the other eligible disability, i.e., HCH, which has to be filled in equal ratio. The candidate selected for the remaining 1 post under OM/HCH category under item No.226 is Mr. Irfan Hussain Parray (DV No. 2230 KMR) although has a percentile of 70.3394 which is less than the aggrieved candidate Sheikh Zaid Ahmad (DV No. 2226 KMR) who has a percentile of 86.8137 , but Sheikh Zaid Ahmad cannot be selected under item 226, as the 2 available vacancies are to be filled in equal ratio with two eligible candidates one each from HCL and HCH in their order of their merit. The Board, on the basis of the reasoning provided above, decided that the inclusion of Irfan Hussain Parray in the selection list was justified.

As, it was found that the candidate was inadvertently allotted item 180/OM/15, whereas, as per his merit and preference, the correct allotment should have been Item no. 226/PSP/1, the Board decided that the necessary corrections in the cadre allotment be done.

Mohd Tahseen Shah	2228 KMR	Unselected	The candidate represented that despite having a percentile of 75.9268 his name has not featured in the provisional selection list whereas another candidate namely Irfan Hassan Parray who has been selected under item No. 226 has a lower percentile of 70.3394.	As the candidate has a 40 percent temporary Locomotor disability and does not qualify the cutoff as an OM candidate. Moreover, he being an HCL (Locomotor Disability) candidate has compared his score with another candidate of HCH (Hearing Impairment) category, who has secured a place under item No. 226 by being the topmost eligible PwD candidate for that item, who has also applied for that item. As such the candidate cannot be considered for inclusion in the Final Selection List.
4.	Sameer Ahmad Ahanger	2135 KMR	Unselected	The candidate requested for consideration of his candidature for item No 224 (CSSD Assistant)	The candidate namely Mr. Sameer Ahmed Ahanger, under OM/RBA category for item No. 224 has submitted two-year diploma in CSSD. As the course pursued by him is of 2 years, instead of one year as prescribed in the indent (10+2 or above with diploma in Medical Assistant and one year training course in CSSD from recognized institute) , the Board decided that the aforementioned candidate does not possess the requisite qualification as per indent and cannot be considered for selection.

The change in the cadre of one candidate namely Mr. Yasir Amin Khan (DV No. 2011 KMR) from 180/OM/PSP15 to 226/PSP/1, has had a cascading effect on the Final Selection List, which is elaborated as under:
