1. Whereas, the J&K Public Service Commission conducted the **Written Test for filling up of the posts of Assistant Engineer (Civil) in Jal Shakti Department, 2023;** and
2. Whereas, the Provisional official answer key was notified and uploaded on the official website of the Commission for information of the candidates vide Notification No. PSC/Exam/S/2023/56 Dated: 02.10.2023, inter-alia notifying that, if any candidate feels that the key to any of the questions is wrong/incorrect, he/she may prefer a representation/objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of notifications along with documentary proof /evidence and the fee of Rs.500/- per question; and
3. Whereas, in response to the said notification, number of objections/representations were received by the J&K Public Service Commission against Provisional Answer Key issued; and
4. Whereas, all the objections/representations were referred to the Committee of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and
5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Answer Key in respect of the said paper;

Now, therefore, in view of the above and on the basis of opinion of the independent team of Experts, it is hereby notified that:-

- a) The changes recommended by the Committee of Experts are hereby adopted and the Final Official Key is annexed to this notification as Annexure A in respect of **Assistant Engineer (Civil) in Jal Shakti Department, 2023.** In terms of Rule 10 (d) of the J&K Public Service

Commission (Conduct of Examination) Rules, 2022 as amended upto date, the marks allocated to the deleted questions **shall be individually added to the marks secured by the individual candidates to ensure that the mark(s) allocated for the question paper as a whole remain unchanged**, at the time of calculation/compilation of award sheet before the declaration of the result;

- b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.
