**NOTICE**

The J&K Services Selection Board, notified the Final Selection List for Pharmacy Domain including that of CSSD Assistant (Item No. 224) of Health and Medical Education Department, pursuant to Notification No. 02 of 2021 dated 26.03.2021, vide Notification No. SSB/SEL/SECY/2023/797-806 dated 14.08.2023.

You had, through the email provided for the purpose, represented for considering your candidature for item No. 224 (C.S.S.D Assistant, Divisional Cadre Kashmir) and the issue was deliberated in the Board in its 232nd Board Meeting, wherein it was decided that instead of one year training course in CSSD assistant (provided in the indent) you were in possession of 2 years training course in CSSD assistant and therefore were not considered for selection for not having the requisite qualification.

However, in the O.A. No. 704/2023 titled Sameer Ahmad Ahanger vs UT of J&K and Ors., the Hon'ble Central Administrative Tribunal, Srinagar Bench vide order dated 06.09.2023 has passed the following directions:


