Whereas, the Higher Education Department, vide letter No. HE/Coll/Coord/Apptt/A.P./2021 dated 05.07.2021 and No. HED-GAZ/85/2022-04 dated 13.04.2022, referred **01 post of Assistant Professor, Industrial Chemistry, under Open category**, to the J&K Public Service Commission, for selection of suitable candidate; *and*,

Whereas, the J&K Public Service Commission, vide Notification No. 06- PSC (DR-P) OF 2023 dated: 01.03.2023, advertised the said post for selection; *and*,


Whereas, written test was conducted on 10.09.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/58 dated: 05.10.2023, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021, as amended up-to-date; *and*,

Whereas, 04 candidates qualified for interview; *and*,

Whereas, the interview/viva-voce of candidates was conducted on 20.10.2023 with the assistance of Experts from outside of the UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related parameters, in pursuance of Rule 45 of the J&K Public Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure** to this Notification.

On the basis of performance in the interview, the weight-age earned in the written test & other attributes, none of the candidates crossed the benchmark as envisaged in J&K Public Service Commission (Business & Procedure) Rules, 2021. As such, no provisional Select List is issued against the post. Objections, if any, may be submitted to the Commission within five days for examination and disposal. No claim, whatsoever, shall be entertained after five days from the date of issuance of Notification.
