
It is further notified that:

- ii. the Jammu & Kashmir Services Selection Board (JKSSB) will call candidates falling in the consideration zone, based on the merit obtained by them for document verification.
- iii. the candidates given in **Annexure "B"** to this notification, **are hereby called upon to appear physically before the Document Verification (D.V.) Committee** of the Board for the verification/scrutiny of their documents/certificates on 01-01-2024 (Monday) at 11.00 AM at JKSSB, Central Office, CPO Chowk, Panjtirthi, Jammu.
The candidates are required to produce following original documents/certificates in original, along-with one self-attested copy of each document/certificate before the D.V. Committee:
 - a. Copy of Online Application Form(s).
 - b. Two Passport size recent colour photographs.
 - c. One original photo ID Proof i.e. Aadhar Card/Voter Card/Pan Card/Passport etc.
 - d. Valid Category Certificate, if belongs to reserved categories.
 - e. Domicile Certificate.
 - f. 10+2 Marks Sheet/Diploma.

- g. Graduation Degree and Diploma in Industrial Fermentation & Alcohol Technology from recognized Institute.
- h. Bonafide certificate on the format prescribed by the Board duly issued by the Controller/Registrar of the concerned University/Institute in respect of candidates, who have obtained the qualification from outside the UT of J&K.
- i. Other documents as per prescribed qualification mentioned in the Advertisement Notification.

The candidate(s) who fail to appear before the respective Document Verification Committee on the scheduled date shall forfeit their right to selection.
