- 2. Marks Card of the requisite Courses passed by the candidate.
- 3. Degree Certificate.
- 4. Date of birth (10<sup>th</sup> class marks card/Diploma issued by the Board).
- 5. Experience/Work Certificate wherever required.
- 6. Valid Reserved Category Certificate, if any and;
- 7. Any other document/Certificate as may be required by the Admission Authorities of the Institute.

### Note:

- As per Section 9(2) of the J&K Reservation Act 2004, 11 seats available in various Reserved Categories were converted to Open Merit due to non- availability of eligible candidate(s) in the respective Reserved Categories and were allotted to the eligible candidates strictly on the basis of merit/preference Course wise as per the eligibility fixed by the SKIMS.
- 2. The admission of the candidates is purely provisional and shall be cancelled in case any information furnished by any candidate proves to be false/fabricated and action as warranted under Law shall be initiated against such candidate(s).
- 3. It is hereby implored upon the Management of the SKIMS to ensure the veracity of documents, particularly the Category Certificates wherever the admission is to be granted in lieu of a Reserved Category.
