- The candidates who have been allotted seats in accordance with their merit/ preferences 1. shall have to join against the said allotted seats upto 08.02.2024 positively and in case any candidate fails to join against his/her allotted seat(s) he/she shall not be eligible to participate in the 2nd Round of Physical Upgradation/Allotment Counselling under any circumstances, if any, conducted by the Board.
- 2. The admission of the candidates is purely provisional and shall be liable to be cancelled in case any information furnished by any candidate proves to be false / fabricated, and action as warranted under law shall be initiated against such candidates.

- 3. It is hereby implored upon the Management of the concerned Colleges/Institutions to ensure the veracity of documents, particularly the Category Certificate wherever the admission is to be granted in lieu of a Reserved Category.
- 4. The Heads of the concerned Collages/Institutions are advised to download the copy of this notification alongwith its Annexure-A from the official website of the Board viz. www.jkbopee.gov.in for reference and record.
- 5. For fee/documents required for admission in the College/Institution, the provisionally selected candidates are advised to contact the concerned College/Institution before admission.
- 6. The seats which shall remain unfilled after the conclusion of this Round of Counselling alongwith the seats, if any, received as short-fall from the concerned Colleges/Institutions shall be filled during subsequent Rounds of Counselling, if any, conducted by the Board.
