- iii) Category Certificate, if any;
- iv) Date of Birth (DOB) Certificate and
- v) Any other certificate required by the College in accordance with the rules.

- 1. All the Heads of the Institutions/Colleges are requested to keep their admission counters open on holidays/off days to facilitate the candidates to complete their admission process well in time.
- 2. The candidate(s) who would conceal any information at the time of admission, the candidature of such candidates shall be cancelled abinitio and fine/penalty shall be imposed upon him/her as may be deemed proper by the Board in accordance with the laid down rules.
