It shall be sole responsibility of the Colleges/ Institutions concerned to ensure proper checking/verification of documents/ eligibility as per the guidelines of MCI/NMC before the candidate is allowed to join the course, he/she is provisionally selected for.

The Colleges/ Institutions shall submit the shortfall, if any, to BOPEE Office, Jammu/Srinagar upto 5.00 PM on **28.02.2025** through e-mail jakbopee@gmail.com / helpdeskjakbopee@gmail.com / coejakbopee@gmail.com.

All participating Institutions/ Colleges shall treat all Sundays and Gazetted holidays as working days especially for the concerned admission sections so that the candidates may not face any problem in completion of their admission formalities.

The admission of the candidates allotted seats during this round of counselling is purely provisional and shall be liable to be cancelled in case any information furnished by any candidates proves to be false/fabricated, and action as warranted under law shall be initiated against such candidates.
2. It is hereby implored upon the management of all Colleges/Institutions to ensure the veracity of documents, particularly the Category Certificates wherever the admission is to be granted in lieu of a particular Reserved Category.
