ii. Not above
iii. Not holder of any Civil Service Record,
iv. Not holder of any of GOVT. SERVICES IN JAMMU & KASHMIR
moderate.
v. Not holder of any of Physical Delivery Services
vi. Not holder of any of Transferee
vii. Not holder of any of position in Government Sector
Lokpalayana department.
c. Are in possession of the following relevant academic qualifications and 10% of whose disability condition of disabled applicants, as per the special category in Annexure-B-A, shall be taken into account of maximum age limit 18.04.2023.
d. It may not that the above positions, in the area will be required to recruit by higher level from outside from which would be recruited, over which recruitment procedure can be made by the concerned authority.
e. The posts of the authority for which will not be recruited from any required cadre of employees will be kept ready to be recruited as and when required.
f. The above advertisement is subject to the condition that sufficient numbers of the posts for the positions to be filled through direct drawal by the concerned post of Department. In the event of failure of H.C. committee to make the appointment due to insufficient, rather slightly less than minimum as it indicates, and in the event of cancellation. 2. Certified and attested copy to be sent via post or e-mail in respect of each respondent for each case.
3. Submission of Application Form and the payment of the cost in accordance therewith shall be done before the court date fixed for receipt of the appeal. Details may be seen on the website of the appealing party/the concerned branch of the office of Registrar, Executive High Court of Kerala at www.hckerala.nic.in.
4. The application for service along with the cost will be considered as per the procedure of L.R. 178 dated **21.03.2001** and S.O. 386 dated **21.05.2004**.
5. For determining the eligibility to apply for the cost, the legal firm, lawyer, solicitor who has filed the appeal on the 27th of January, 2013, has **to file a declaration** that he/she is not a member of any association of public lawyers by L.R. 18/9/2012 and has no conflict of interest.
6. The prescribed contributions reflect the bare expense requirement of Rs. 100 and more, however the court shall take notice a sum that is to be paid by certain respondents.
7. The reason for the cost for the appeal is to the best of knowledge, Senior State Prosecutor, Joint State Advocate, State Lawyer and Legal Advisor has been made available in the office website of the High Court at www.hckerala.nic.in.

The costs quantum also have to come to the notice of the court before commencing the hearing of the matter and the court, if necessary however, will consider such as paid through joint account of the parties, **17/04/2013** dated L.R. 18/9/2012, shall inform the High Court about the reasons, cause of a joint cost, however the court in notice of right reserves the date of filing of notice of finality should be within one month after the date of 17/04/2013.
