The National Board of Examinations in Medical Sciences (NBEMS), New Delhi, has declared the Result for MDS-2025 on **15th May, 2025**. Accordingly, the Ministry of Health and Family Welfare, Government of India, has provided the results of candidates from the Union Territories (UTs) of Jammu and Kashmir (J&K) and Ladakh, who appeared in the National Eligibility Entrance Test (NEET) for admission to MDS Courses for the 2025 session, to the Board on 27th May 2025.

The NEET-MDS 2025 Roll Number-wise list of candidates is annexed as **Annexure-A** to this Notification. The interested candidates can check their results on the official website of the Board, www.jkbopee.gov.in, only.

The candidates who have appeared in NEET MDS-2025 under All India Quota & whose Roll Numbers do not figure in **Annexure-A** to this Notification but belong to UT of J&K/Ladakh, and are willing to participate in the counselling for seats in UT of J&K shall have to submit all the relevant documents i.e. NEET MDS 2025 Score Card, Domicile Certificate, Category Certificate, if any, physically at the BOPEE Office Jammu/ Srinagar up to 04-06-2025 (till 04:00 p.m.) during working days only.

Further, the Notification regarding Online Registration of eligible candidates shall be issued separately, and the candidates in their interest are advised to remain in constant touch with the BOPEE website regularly and to keep all the relevant documents ready for registration, whenever asked for.
